DESCRIPTION OF CONTEST:

From October 10, 2023 [09:00 AM PST] to November 17, 2023 11:59 PM PST, submit an application for a chance to gain admission into the AWS Education Accelerator and receive up to either one thousand dollars (\$1,000 USD) in AWS Activate Credit or one hundred thousand dollars (\$100,000 USD) in AWS Activate Credit, as determined solely by your affiliation with AWS Activate Providers. NO PURCHASE NECESSARY. VOID WHERE PROHIBITED. Terms and conditions apply.

By submitting your application for admission into the AWS Education Accelerator (“**Contest**”), you agree to be bound by these Terms and Conditions. NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

From October 10, 2023 09:00 AM PST to November 17, 2023 11:59 PM PST (“**Contest Period**”), submit an application for a chance to gain admission into the AWS Education Accelerator and receive up to either one thousand dollars (\$1,000 USD) in AWS Activate Credit or one hundred thousand dollars (\$100,000 USD) in AWS Activate Credit, as determined solely by your affiliation with AWS Activate Providers. To qualify for the Contest, your startup company (“**Startup**”) must: (i) be self-funded or in the pre-Series B stage of the fundraising process, (ii) have a fully-functioning company website, and (iii) have been founded within the past ten (10) years. Startups may be eligible to receive up to one hundred thousand dollars (\$100,000 USD) in AWS Activate Credit if the Startup: (i) has previously joined the AWS Activate Program and has an Organizational ID, and (ii) has not previously received one hundred thousand dollars (\$100,000 USD) or more in AWS Activate Credit from an Activate Provider or redeemed such amount. Startups who have not previously joined the AWS Activate Program may be eligible to receive up to one thousand dollars (\$1,000 USD). Must be at least 18 years of age. Excludes individuals living in Argentina, Brazil, France, Germany, Italy, Mexico, Philippines, Quebec, Russia, Spain, Thailand, Vietnam, Cuba, Iran, Syria, North Korea, and the region of Crimea. All eligible entries received during the Contest Period will be evaluated, and up to fifteen (15) Startups will be selected to participate in any cohort, based on the strength of the application and the Startup’s ability to demonstrate early-stage traction with data-driven solutions aimed at enhancing the teaching and learning experience and improving educational outcomes.
