Onsite Engagement Activities Terms & Conditions

The AWS Summit Hong Kong Engagement Activities (“Offer”) begins at 9:00:00am Hong Kong Time (“HKT”) on 23 May, 2023, and ends at 5:30:00pm HKT on 23 May, 2023, or when supplies of AWS Souvenir (defined below) are exhausted, whichever occurs first (“Offer Period”). The number of AWS Souvenir is limited. The AWS Summit Hong Kong Onsite Engagement Activities include two parts: 1) Stamp Collection and 2) Knowledge Quiz.

Eligibility: Open to individuals who are registered attendees of the AWS Summit Hong Kong 2023 (the “Event”), scheduled to take place physically at Convention Hall, Hong Kong Convention and Exhibition Centre, Wan Chai, Hong Kong. Offer is void where prohibited. Amazon Web Services, Inc. (“AWS”) and its affiliates’ employees and their immediate family members, and associates enrolled in the Amazon Associates program, are not eligible to participate. Limit one entry per person.

All eligible entries received during the Offer Period will be evaluated and the winners in Knowledge Quiz will be selected, based on the following rules:

1) Stamp collection

Participants must collect a specific amount of stamps on their stamp collection card during the Offer in order to be eligible for redemption of a souvenir. Participants can collect a maximum of 21 stamps. To be eligible to redeem a souvenir, participants must collect a minimum of 9 stamps out of 16 sponsor booths **AND** all 5 stamps from the AWS booths. Each booth will have only one type of stamp, and the stamps of each booth will be different so that participants cannot obtain duplicates of the same stamp.

Verification of stamps: Participants will be required to present their stamp collection card at the redemption booth for verification. Stamps that are torn, damaged or duplicated will not be accepted.

Souvenir redemption: Each eligible participant can redeem one of the two souvenirs: (1) an AWS bucket hat, size M or L, subject to availability, **OR** (2) an AWS picnic mat. Souvenirs will be available for redemption from 2:30pm to 5:30pm during the Offer or until all souvenirs have been given away. The Stamp collection offers a total of 700 AWS bucket hats and 300 AWS picnic mats.

2) Knowledge Quiz

Knowledge Quiz will be hosted at 2:15:00pm Hong Kong time, at Theatre 1, 2, 3, 4 & 5. Participants need to participate in the Knowledge Quiz via Kahoot by joining the Offer– during the Offer period and will need to answer 4 questions within the Offer. Each question will be given 4 available options and only 1 option will be the correct answer. The correct answer will be defined by the Offer Admin – AWS representatives. Participant will be assigned a random nickname during the quiz by Kahoot. No information will be collected during the quiz. At the end of the Knowledge Quiz, Kahoot will identify the top 5 players who answered questions correctly and were the fastest to do so. Top 5 players will need to

identify themselves to the AWS representatives at each Theatre. AWS representative will verify their Kahoot user name and distribute the prize.

The Knowledge Quiz shall give out a total 25 pieces of AWS camping chair as AWS Souvenir. Participants who are qualified for the prize could redeem the AWS Souvenir physically at the Theatre by 2:20pm.
